A Proclamation Issued to Amend the Revised Mass Media Agency Establishment Proclamation of the Amhara National Regional State

WHEREAS, it has been found necessary to improve and make more clear the provisions concerned to the administration procedure of the agency's professionals and supporting staff and finance administration of the Amhara Region mass media agency establishment proclamation No 88/2003, that is in effect to be implemented successfully;

NOW, THEREFORE, the council of the Amhara National Region, in accordance with the power vested in it under Article 49 sub-articles 3/1/ of the Revised constitution of the National Region, here by issues this proclamation.

## 1. Short Title

This proclamation may be cited as "a revised mass media agency of the Amhara Region establishment proclamation amendment proclamation No 200/2012"

#### 2. Amendment

The revised Amhara Region mass media agency establishment proclamation No.88/2003 is amended as follows by this proclamation:

A/ Alphabet /c/ of sub –article /1/ of Article 6 of the proclamation is deleted and replaced by the new alphabet /c/.

C/ Deputy managers, as may be necessary.

B/ sub- article /7/ of Article 9 of the proclamation is deleted and replaced by the new sub-article /7/.

/7/Recognizing the agency's work situation and in harmony with the region civil service laws, regulations and derectives, decide the agency's journalists, production and technic professionals, as well as supporting staff recruitment, salary scale, perdiem and other fringe benefits that has been presented studying by the agency's management.

- /ሥ/ ከአዋጁ አንቀጽ 12 ቀጥሎ የሚከተለው አዲስ አንቀጽ 13 የተጨመረ ሲሆን በዚሁ አዲስ አንቀጽ መግባት ምክንያት ተከታዩቹ አንቀጾች ወደፊት ተሽጋሽገዋል፡፡

- C/ Next to sub-article/7/ of Article 9 of the proclamation, the following new sub- articles 8 and 9 provisions are included; the remaining provisions are arranged forward.
- /8/ cause making and preparing the administration manual draft, of journalists, production and technic professionals, as well as supporting staff, be submitted; approving this by examining and giving direction to be in effect;
- /9/ pursuant to finance, procurement and property administration laws, regulations and directives that are applicable in the region, approve by examining similar finance and property administration manuals which are in harmony with the agency's work situation that are submitted by preparing; cause it to be in effect.
- D/ Alphabet/c/ of sub-article /3/ of Article 11 of the proclamation is deleted and replaced by the following new alphabet/c/.
- /c/pursuant to directives which shall be issued by the board; recruit, administer and dismiss the agency's journalists, production and technic professionals, as well as supporting staff.
- E/ Next to Article 12 of the proclamation, the following new Article 13 is included; pursuant to the entrance of this new Article, the subsequent Articles are arranged forward.

#### /13/ ስለቅሬታ አቀራረብና አወሳሰን

- 1. የድርጅቱ 'ጋዜጠኞች፣ የፕሮዳክሽንና የቴክኒክ ባለሙያዎች እንዲሁም ድጋፍ ሰጭ ሥራተኞች በዚህ አዋጅ መሥረት የሚያነሷቸው ቅሬታዎች ለቦርዱ ቀርበው ውግኔ ያገኛሉ።
- 2.ቦርዱ በፍሬ ነገር ክርክር የሚሰጠዉ መሳኔ የመጨረሻ ይሆናል፤ ሆኖም መሳኔመ የሕግ ስህተት አለበት ብሎ ያመነ ወገን ቦርዱ መሳኔ በተሰጠ በ30 ቀናት መስተ ይግባኙን ለክልሉ ጠቅላይ ፍርድ ቤት ማቅረብ ይችላል፡፡

#### /13/ Grievance Submission and Decision Making

- 1. Pursuant to this proclamation, the raising grievances, of the agency's journalists' production and technic professionals, as well as supporting staff, shall get decision submitted to the board.
- 2. The decision of the board on question of facts shall be tried; provided; however, that any one of the parties May appeal to the regional supreme court on question of law within 30 days from the late of the desion of the board.

#### 3. Effective Date

This proclamation shall comeinto force as of the date of its publication in the Zikre-Hig Gazettee of the Rgional State
