A proclamation Issued to provide for the Amhara National Regional State Leadership Academy Establishment and powers and Duties Determination Proclamation

WHERE AS, it has been found necessary to establish organization used to develop effective leasership that ensures the sustainability of renewal journey, to give appropriate response for the renewal forum request and achieve the country's vision properly, be initiating scientific and sustainable ideas, having greate substance with respect to education, training , research, observation, analysis and internalize in the Region.

WHERE AS, it has been found necessary to establish the strengthened entity that shall perform with integrated and organized manner of periodically rendered trainings and duties of education, study, research and rendering of the councelling service, that shall be conducted in this aspect, for leaders and professinals, that serve be appointed or assigned by different rural, as well as, city administrational levels;

NOW THEREFORE, the Council of the Amhara Region, pursuant to the powers vested in it under Article /49/, sub-article 3/1/ of the Revised National Regional Constitution, hereby proclamas this proclamation.

PART ONE GENERAL

1. Short Title

This proclamation may be cited as "the Amhara National Regional State Leadership Academy Establishment and Powers and Duties Determination Proclamation No. 221/2014".

2. **Definition**

- **1.** Unless the context otherwise requires, in this proclamation:
- a. "Trainee" means any Natural person who are allowed to participate in any training action plan and elected with criteria to be issued by Academy, following this proclamation;

- b. "Leadership " means any person serves as a head to be appointed or assigned in government sectors that are included in rural, as well as, city administrational levels in the Region; and, includes leaders of public associations and private sectors;
- c. "Professional" means any person who is employeed or assigned and serves in government sectors, government development organizations or in private institutions in the region.

4. ስለመቋቋምና ተጠሪነት

- 2. አካዳሚው በሙያ ስራ ረገድ የሚኖረው አስተዳደራዊና አካዳሚያዊ ነጻነት እንደተጠበቀ ሆኖ፣ ተጠሪነቱ ለብሔራዊ ክልላዊ መንግስቱ ርዕሰ መስተዳድር ይሆናል፤
- 3. የአካዳሚዉ ዋና መስሪያ ቤት በባህርዳር ከተማ ሆኖ እንደአስፈላጊነቱ በክልሉ በማገኙ ሌሎች *ዉ*.ስጥ ቅርንጫፍ ስፍራዎች ወይም ማስተባበሪያ ጽ/ቤቶችን ሊያደራጅ ይችላል፡፡

2. Any provision stipulated in masculine gender under this proclamation, shall also equally applicable for feminine gender.

3. Scope of Applicability

This proclamation shall be applicable on types of work organized herein under the Academy and education, as well as, trainees of training.

PART TWO Establishment, Objective, Power and Organization of the Academy

4. Establishment and Accountability

- 1. The Amhara National Regional State
 Leadership Academy(herein after, referred to
 as "the Academy" is hereby established, as
 autonomous and having juridical personality of
 the Regional Government higher education,
 training and research institution by this
 proclamation;
- Without prejudice to the administarional and economic freedom, the Academy shall be accountable to the Head of the National Regional State, with regard to professionalism;
- 3. The Head office of the Academy shall be in Bahair Dar Town; as deemed as necessary; it may organize a branch or coordinating offices in other places of the Region.

5. Objectives

The Academy shall have the following objectives, pursuant to this proclamation:

- To render a standardized education and training for leaders and support professionals who serve the public, rendered a leadership position with different administrational levels in the Region; to have a borad knowledge about management science, skillful and highly ethical;
 - 2. To produce the next leaders and professionals with efficiency and quality, who speed up the transition of the Leadership Academy;
 - 3. To ensure the regional, as well as, the country sustainability of renewal journey, by producing the different levels of leader, having a better efficiency and competitive capacity;
 - 4. To produce a leader, who shall work with effort to the use of the whole people and generate sicentific and problem solver ideas, based on the study, research, observation and analysis and supported with reliable evidences;

6. Principles

The Academy shall carry out activities following indicated principles herein under;

- 1. To hold development and democratic outlook and thinking;
- 2. To learn,negotiate and discover always;

- 3. To respect and cause to respect constitutional system that the region is organaized;
- 4. To believe with diversity, public decisive and sustainably use;
- 5. To establish systems of transparency and accountabilty;
- 6. To lead programs of chanage ahead of others.

7. Power and Duty of the Academy

The Academy shall have the following particular powers and duties, pursuant to this proclamation:

1. Render the short, medium and long term education and trainings that enable to produce with efficiency and quality and supported with modern study, research, observation, analysis and create awareness on activities of each level leader and professionals with the countries policies and strategies; prepare modules that serve for trainings; and organize other similar educational materials.

 Design particular educational and training action palns, starting from regional and country wise development policies, strategies, principles and objectives; cause to be effected on its approval by the board;

- 6. በየጊዜው የሚሰጣቸውን ትምህርትና ስልጠናዎች በተመለከተ የግምገማና የምዝና ሥርዓት ቀርጸ በተግባር ላይ እንዲውል ያደርጋል፤
- 7. በክልሉ መንግስት መስሪያ ቤቶች የሚያገለግሉ ባለሙያዎችን የሥራ አመራር ብቃት ለማጎልበትና ለማሳደግ የሚረዱ የአጭርና የመካከለኛ ጊዜ ስልጠናዎችን ይንድፋል፣ ያሰለጥናል፣
- 8. በተናትና ምርምር ስራዎች የተገኙ ውጤቶች ያሳትማል፣ ለተጠቃሚዎች ያሰራጫል፤
- 9. ቦርዱ በሚያወጣቸው የምልመሳ መስፌርቶች መሰረት ሰልጣኞችን ይቀበላል፣ የዕለት ተዕለት ግንባታቸውን በቅርብ ይከታተላል፤

- 3. Render certificate for those who completed the rendered educational and training action plans; and, as deemed as necessary, pursuant to other related laws of the Country's Higher Education Proclamation No. 650/2008, shall render Diploma or Degree;
- Conduct studies and researches help to improve its own education and training rendering periodically, as well as, to promote execution capacity of the regional government institutions;
- 5. Render trainings and counceling services that emphasize on leadership philosopy and development of code of conduct, pursuant to request submmitted from government sectors or institutions, government development organizations and private sector;
- 6. cause to be implemented with regard to trainings that it renders periodically, designing the evaluation and assessment procedure;
- 7. Design the short and medium trainings that help to strengthen and promote management efficiency of professionals, in the regional government sectors; and shall train the trainees;
 - 8. Publish and distribute results for users, found by study and research activities;
 - 9. Receive trainees, pursuant to selection criteria that shall be set by the board; follow up their promotion closely;

- 11. Follow up closely the performance of trainees after training in jobs; conduct a research of training effectiveness; concerning to findings, it shall report to the pertinent body; and design better work procedures strating from it;
- 12. prepare and conduct different educational seminars, workshops, conferences and workshops; and participate on such type of forums when they are called;
- 13. Establish work relationship with the regional and federal government institutions, which are equal to it in status and having similar objectives; render training with collaboration; it may create relationship and interchange best practices with similar training and research institutions in foreign country, coincide with the country's foreign policy principles and objectives;
- 14. facilitate conditions that used to get revenue, by preparing management training, counceling service and the the study projects; as deemed as necessary, it cause to pay proportional for rendering serveces;
- 15. Own property, enter into contract, sue and be sued by its name;
- 16. Perform other related activities that are used to

- 3. Deputy Director Generals appointed with the Head of Gevernment, proposed with the Board;
- 4. Academic Commission;
- 5. The number of Academic departments shall be determined with their necessity for the activity;
- 6. Other support staffs, necessary for the activity.

PART THREE

Internal Organization, Duty and Procedure of the Bodies of Academy

9. Establishment, Duty and Procedure for the Management Board of the Academy

- 1. The management board of Academy /herein after called "Board"/ is established as the higher power entity of the academy with this proclamation;
- 2. The Board shall be accountable to the Head of the Region, and shall have the following members:
 - a. The Head of the Region or the Head of the office, nominated by the Head of the Region
 chair person;

- 2. The commission, shall have members determined their numbers with the board; including its chair person. The particulars shall be determined by the directives, that shall be issued for the implementation of this proclamation.

- 6. Issue the education and the training appropriateness and quality assurance and the system of trainees assessment, that is rendered with the Academy; determine rendering and standards of General entrance and exit examination;
- 7. Pursuant to policies that shall be rendered with the board, the commission shall issue with regard to administration of trainees, the education and training issues, selection procedure of Heads of the education, recruitment, promotion, benefits, discipline and salary of the teachers;

- Book accounts and finance of the Academy, as well as, archieves and documents of property, shall be audited by Auditor General of the Region or auditors, nominated by the Board.

21. Transfer of Right and Duty

Rights and Duties of the Management Institute Establishment Proclamation No.137/2006, is transferred to the newly established Leadersip Academy, pursuant to this proclamation.

22. Power to Issue Regulation

The Council of the Regional Government may issue Regulation, which is necessary for the full implementation of this proclamation.

23. Power to Issue Directives

The Board may issue particular directives, that are necessary for the full implementation of provisions of this proclamation; and, regulations that shall be issued, pursuant to this proclamation.

24. Rffective Date

This proclamation shall come into force as of its publication date in the Zikre-Hig Gazzettee of the Regional Government.
