NOW, THEREFORE, the Council of the Amhara National Region, in accordance with the powers vested in it under the provisions of Article 49 subarticle 3(1) and (10) of the Revised Constitution of Region, hereby proclaims as follows.

## PART ONE GENERAL

### 1. **Short Title**

This proclamation may be cited as "the 2015/2016 Fiscal Year Budget Approval and Determination of its Administration of the Amhara Regional State Proclamation No.228/2015."

### 3. The Law of Budget Administration

The Budget Administration of the Regional State shall be directed pursuant to the Amhara National Regional State revised financial Administration Proclamation No. 178/2011 and by the directives and working procedures issued by the Bureau of Finance and Economic Development.

### 4. <u>Budget Administration Power of the Council of</u> the Regional Government

Without prejudice to the provision of Article 18 of the Amhara National Regional State Budget Administration Proclamation No. 178/2011 the Council of the Regional Government shall decide and implement when additional income is gained from foreign loan, from aid or domestic loan aid, or from other sources for new activities unspecified in the proclamation hereof, or for those capital and recurrent activities approved in the budget year, and the Regional Council shall thereby approve same as a supplementary budget when holding its session.

## 5. Budget Administration Power of the Executive Organs of the National Region

- A. The Heads of the Government Offices of the Amhara National Regional State are hereby authorized to administer the budget appropriated, pursuant to this proclamation, for the services of their respective departments and projects.
- B. Nationality administrations having a council at the Zonal level are here by fully authorized to administer the budget based on the budget ceiling allocated to the Zone, woreda and city administrations by this proclamation.
- C. The Woreda City administration is hereby fully authorized to administer the budget based on the budget ceiling allocated to it by this proclamation.

D. Where Executive Organs of all level require disbursement from the budget allocated to them, the Head of Finance and Economic Development Bureau is hereby ordered, pursuant to this proclamation, to disburse same from the National Regional State Revenues and other sources.

### 6. <u>Authority to Administer Revenue of Woredas</u> and <u>City Administrations</u>

The state treasury total Budget appropriated for the woredas and city Administrations during budget allocation shall include the regular revenue colleted by the woreda or city administration and the subsidy budget provided by the Regional Government.

- A.Where woredas or city administrations collect recurrent revenue exceeding to their collecting plan, from the revenue collected beyond plan of 50% shall be utilized by the Woreda or City Administration, if the Amhara National Regional State Finance and Economy Development Bureau allows in same; being proclaimed by the Woreda or City Administration Council thereof.
- B.Cause to submit the amount of money that are issued as an additional budget and the particulars of expenditure, that are allowed to use budget, that are collected over the plan of the woreda or city administration to the regional Finance and Economic Development Bureau; as well as, submit treasury account of 50% share of the region to the Finance and Economic Development Bureau;

- C.The provision indicated under sub article /A/ of this article shall apply only where Weredas and City Administrations notify the revenue they will collect beyond plan up to June 7, 2015 to the Bureau of Finance and Economic development. After 7 of June 2015, any Revenue that shall be collected beyond the plan, submit a treasury account to the finace and Economic Development Bureau.
- D.Weredas and City Administrations, which plan to collect regular revenue beyond the state treasury total budget appropriated on the basis of grant formula, shall utilize the amount of revenue equivalent to the total budget appropriated to them from the state treasury on the basis of grant formula.
- E. Where, the Woredas or city Administrations that has found the Revenue, by formula shall be the Revenue of the Region.

### 7. Power of Budget Transfer

The power to transfer Budget is vested with the bodies, pursuant to this proclamation, indicated herein under.

## A/ The Amhara National Regional State Finance and Economic Development Bureau shall transfer Budget:

 From appropriations made for recurrent Budget of a Government Office to Previously appropriated or non appropriated Recurrent or Capial Budget of another Government Office;

### 9. Special Subsidy Usage of Urbans Development

- A. Thosese citiy Administrations, for which special subsidy is made for them under by Article 2/ II (A) 15 of this proclamation, shall implement same only for the appropriated operations. So, the regional finance and economic development bureau is given the power, by this proclamation to control the proper implementation of budget.
- B. In accordance with Article 2/ II (A) 15 of this proclamation, the allocated budget of 530 million birr fund for cities development of Bahir Dar, Gondar, Dessie, and kombolcha's shared budget, the of urbans envroment program (ULGDP) shall be calculated from each share and shall be matching fund of the region.
- C. The city Administrations that shall, use special Support of urban developments, have a responsibility of only to use the allocated budget for the specified objective, of the special support of urban development. These cities are expected to allocate their own budget share for the urban service Revenue.

### 10. <u>City Service Revenue</u>

- A. In accordance with Article 2(II) (C) of this proclamation, cities utilization of budget allocated with city service revenue shall be based on the effective municipalities and city services finance administration councl of Regional Government Regulation No 37/2006.
- B. Where cities accumulate city service revenue, more than the plan being decided with the concerned body, shall be sent to the Finance and Economic Development Bureau; however, until this will be done, those cities have the power to implement the city serveice revenue.

C. In accordance with Article 2/II/ C of this proclamation, cities allocated with revenue, concering to budget utilization, by preparing action plan for what purpose they apply, and should submit report to Finance and Economic Development Bureau; and shall be approved the council of the Region.

### 11. Internal Revenue

- A. In accordance with Article 2/II/B sub-number /1/ upto /6/ of this proclamation, sectors that are allocated internal revenue concerning to budget utilization, shall be pursuant to effective proclamations, regulations and directives that used by collecting internal revenues.
- B. Where those Sectors collect internal revenue, more than the plan being decided with the concerned body, shall be sent to the Finance and Economic Development Bureau; and shall be approved by the council of the Region; however without prejudice, to this decision, they shall have a power to implement the Internal Revenu that collected more than the plan until it is implementec.
- C. In accordance with Article 2/II/B, sub-number 1 up to 6 of this proclamation, sectors that are allocated internal revenue concerning to budget utilization, by preparing action plan for what purpose they apply, and should submit report to Finance and Economic Development Bureau and Offices found at all levels.
