A Proclamation Issued to provide for the
Revised Establishment, Organization and
Determination of their Powers and Duties of
the Amhara National Regional State
Executive Organs.

በ2008 ዓ.ም መባቻ ላይ የተካሄደውን የብሔራዊ ክልላዊ መንግስቱን አስፈፃሚ አካላት አደረጃጀት ለውጥ ተከትሎ በክልሉ መንገድና ትራንስፖርት ቢሮና በንጠር መንገዶች ኮንስትራክሽን ኤጀንሲ መካከል የተደረገውን የስልጣንና የኃላፊነት ድልድል ይበልጥ ለማጥራት ይቻል ዘንድ በስራ ላይ ያለውን አዋጅ ቁጥር 230/2008 ዓ.ም ማሻሻል አስፈላጊ ሆኖ

የአማራ ክልል ምክር ቤት በተሻሻለው የብሄራዊ ክልሉ ህገ-መንግስት አንቀፅ 49 ንኡስ አንቀፅ 1 (3) ድን*ጋጌ* ስር በተሰጠው ስልጣን መሰረት ይህንን አዋጅ አውጥቷል።

1. አምር ርአስ

2. ማሻሻያ

የተሻሻለው የአማራ ብሄራዊ ክልላዊ መንግሥቱ አስፈፃሚ አካላት ማቋቋሚያ፣ ማደራጃና ስልጣንና ተግባራት መወሰኛ አዋጅ ቁጥር 230/2008 ዓ.ም እንደሚከተለው በዚህ አዋጅ ተሻሽሏል፦ WHERE AS ,it has been found necessary to revise the Proclamation $N_{\underline{0}}$ 230/2015 to scrutiny more the rendered powers and responsibilities between the regional road and transport bureaus and the rural roads construction agency following to the organizational change of the national regional state executive bodies,

NOW, THEREFORE, the council of Amahra Region in accordance with the powers vested in it under subarticle 3(1) of Article (49) of the revised national constitution, the region hereby issued this Proclamation.

1. Short Title

This Proclamation may be cited as "The Revised Executive Bodies' Establishment Proclamation Amendment Proclamation No 248/2017."

2. Amendment

The Revised Amhara National Regional State Executive Bodies' Establishment, Organization and Determination of their Powers and Duties Proclamation No 230/2016 is revised by this Proclamation as follows:

ተዋሳኝ መንገዶችን 965 ቀኝ 5. የገጠር አካባቢዎችን 93ባታ ጨም**ሮ** ለመንገድ የሚያስፌልገውን የመሬት AP2.Bo መጠን **አ**ያጠና ስልጣን ላለው የክልሉ *መ*ንግስት አካል በማቅረብ ያስወስናል፣ መሬቱ የግለሰብ ፣ የቡድን ወይም የድርጅት ህጋዊ ይዞታ ከሆነ ደግሞ እንደ አግባብነቱ ለመሬቱ ትክ ቦታ እንዲሰጥና ወይም በመሬቱ ላይ ላረፉ ወይም ለሚገኙ ንብረቶች መሠረት ተመጣጣኝ ካሳ እንዲከፌል ሁኔታዎችን ያመቻቻል፤

3. አዋጁ የሚወናበት 2ዜ

ይህ አዋጅ በክልሉ *መንግ*ስት ዝክረ-ሕግ *ጋ*ዜጣ ታትሞ ከወጣበት ቀን ጀምሮ የፀና ይሆናል፡፡

The following new sub-article (5) stipulated here in under is incorporated next to sub-article (4) of article 18. Due to the incorporation of this additional provision, the provisions from sub-article (5) up to sub-article (30) are arranged from sub-article (6) up to sub-article (31) for ward.

5. Submit to the authorized regional government for approval by studying periodically the extent of land required for road construction activities including the adjacent surrounding of rural roads, and if the land is a legal land holder of an individual, team or institution; properly make a suitable condition for the land to be replaced and /or/ appropriate compensation to be paid for properties placed or found on the land in accordance with law.

3. Effective Date

This Proclamation shall come in to force as of the official date of its publication in the Zikre –Hig Gazette of the regional state.
