

3. The regional executive committee has been given the authority to make the Megeleta Oromiya Newspaper be issued once in a month or as necessary. The newspaper will be prepared by the Oromo Council only.

4. In regard to any and all legal matters to be cited, this newspaper will be cited as Megeleta Oromiya newspaper. It is the superior legal and notice newspaper of the various newspaper to be issued by any Oromiya Council.

5. Any court issued in Megeleta Oromiya newspaper.

a) Any law, provision, rule, decision, order, notice, and all rule taken from these.

b) It has to take down the name, appointment, work, and signature of a person occupying and duty for the time in any of the transitional administration service in the region.
