NOW, THEREFORE, in accordance with the Revised Constitution No. 46/2001 Article 49 Sub-Article 3 (a) of Oromia National Regional State it is here by proclaimed as follows.

PART ONE GENERAL

1. Short Title

This Proclamation may be cited as the "Oromia National Regional State Micro and Small Enterprises Development Agency Establishment Proclamation No. 146/2009."

2. Definition

In this Proclamation, unless the context requires otherwise:

- 1) "Bureau," means Oromia Trade, Industry and Transport Bureau.
- 2) "Micro Enterprise," means businesses with a paid up capital not exceeding Birr 50,000 not employing more than 10 employees, and excluding technological and consultancy services.
- 3) "Small Enterprise," means businesses with a paid up capital of above Birr 50,000 and not exceeding Birr 1,000,000 employing above 10, but not exceeding 50 employees and excluding technological and consultancy services.
- 4) "Agency," means Oromia National Regional State Micro and Small Enterprises Development Agency.

3. Gender Reference

Where the provisions of this Proclamation are set out in the masculine gender shall apply to the feminine.

4. Establishment and Accountability

- 1) The micro and small enterprise development here in after referred to as the "Agency" is hereby established by this proclamation.
- 2) The agency shall be accountable to the Oromia Bureau of Trade, Industry and Transport.

5. Office of the Agency

The head office of the Agency shall be in Finfinne and may establish branch offices as may be necessary.

Powers and Duties of the Agency The agency shall have the following power and duties: 1) To eliminate poverty and unemployment problems both in towns and rural areas, it prepares policy, rules and strategy that help to expand micro and small enterprise development, and implement the same upon approval. 2) Creates the awareness of the society in the region and for the unemployed to be engaged in micro and small enterprise development activity and create their own job, so as to reduce unemployment. 3) To help the undergoing activities for the realization of a speedy development and eliminate poverty, it registers the unemployed of the region, work with the society to recruit those who should have priority and make the enterprises to inter into activity. 4) To let the micro and small enterprises inter into activity, it gives short term training with the concerned bodies. 5) To enable the society to participate in micro and small enterprises, it identifies job opportunities together with governmental organizations which have open posts, coordinate the activity, arranging ways in which they can get credit. 6) It encourages, registers, and provides authentication certificate to micro small enterprises organized starting with 3 members. 7) Follow up, supervise and inspect policies and rules issued for micro and small enterprise development activities.

- 9) Investigate resources and job opportunities of the region for micro and small enterprises development activities, and implement the same.
- 10) Provides extension service to micro and small enterprises, and establish one service center; implement the same; provide advice.
- 11) Provide information and advice on sources of raw materials, investment opportunities, industry, and skilled labour, training materials, suitable and alternative technologies, machinery, market opportunity, new industrial products, distribution of works, credits and etc.
- 12) Identifies training interests of workers and managers of industries and micro and small enterprises; give trainings; organize training with the concerned body; follows its outcome.
- 13) Improve working system so as to expand modern trade.
- 14) Conduct market research on products of industry and micro and small enterprises, and arrange exhibition places for them.
- 15) Conduct research on modern technologies that are necessary to expand and develop micro and small enterprises products.
- 16) Provide trade development service for the expansion of micro and small enterprises, so as to make them the bases for medium and big industries.

- 22) It provides information service, trade administration and legal advice, and also training so as to expand micro and small enterprises, trade and industry.
- 23) It creates the awareness of the society, the administrative bodies, stakeholders and beneficiaries concerning the objective and uses of micro and small enterprises; organize the same; and shall make to take part in it.
- 24) Provides audit service to those micro and small enterprises organized so far.
- 25) For success of the objective micro and small enterprises, it coordinates shareholders macro enterprises; it coordinates shareholders and preparing regulation for its implementation.
