PROCLAMATION

1. Short Title

This Proclamation may be cited as the
"Oromia Investment Administration
Establishment (Amendment) Procla-
mation No.18/1997."

2. Amendments

The Oromia Investment Adminstration
Establishment Proclamation No.2/
1995 is hereby amended as follows:

1. Article 2(5) is hereby deleted and
replaced by the following new sub-
article(5):

“5. Investment Proclamation means

37/1996 of the Federal Govern-
ment.”

2. Article 2 is hereby amended by
adding the following new sub-arti-
cle(8):

“8. Regulations” means the Invest-
ment Incentives Council of Minis-
ters Regulations No. 7/1996.”

"1. The Board shall be accountable to the Committee and shall be constituted as follows:

- (a) The President of the Regional State Chairman
- (b) The Head of the Economic Sector of the Council Vice chairman
- (c) The Head of the Agricultural Development Bureau ... Member
- (d) The Head of the Works and Urban Development Bureau Member
- (e) The Head of the Investment Office .. Member and Secretary
- (f) The Head of the Bureau concerned with the area of investment Non-voting member.

5. Article 6 is hereby amended by adding the following new sub-article (3):

"3. The Board may establish its secretariat under the auspices of the Office of the Council of the Region Government."

6. Article 7 is hereby deleted and replaced by the following new Article 7:

"7. The Board shall have the following powers and duties:

- (a) to initiate policy matters with respect to investment and submit same to the Committee for approval;
- (b) to issue necessary directives for the expansion of investment activities in the Region;
- (c) to lead and control the implementation of investment activities;
- (d) to give decisions on appeals submitted to it by investors;
- (e) to decide on land proposed to be allocated for investment activities;
- (f) to decide on urban land administered on rent where required investment activities or to delegate concerned organ for same purpose

7. The following new Article 8 is hereby added next to Article 7:

“8. Powers and duties of the secretariat of the Board.

(a) to examine, evaluate and suggest on investment related issues in consultation with concerned organ;

(b) to receive appeals of investors lodged against the decision of the Investment Office, zonal administration and Investment Committee and submit it to the Board for decision;

(c) to carry out other duties as may be assigned to it.”

8. The former Articles “8-25” are hereby re-numbered to read as Articles “9-26.”

9. Article 10 is hereby deleted and replaced by the following new Article 10:

“Powers and Duties of the Office

1. The Office shall have the following powers and duties:

(a) to issue, renew and revoke investment certificates in accordance with the Investment Proclamation requests which do not fall within the jurisdiction of the Ethiopian Investment Authority;

(b) to receive and the land request made by domestic investors with investment capital of over 5 mill. Birr or a joint investment of foreign and domestic investors and submit it to the Board for decision;

(c) to initiate policy matters and directives for investment activities in the Region;

- (i) to issue an operating license and register business organizations in accordance with the relevant laws and directives on behalf of the respective Bureau;
- (j) to issue a license within 30 days upon the fulfillment of all the requirements as per the provisions of this Article;
- (k) To carry out other duties as may be assigned to it.
