**Proclamation No. 190/2015, To
Amend the Revised Organization,
Duties, Ethics of the Members and
Meeting Procedures of ‘Caffee’, Proc-

Whereas, it has become necessary to amend the Revised Organization, Duties, Ethics of the Members and Meeting Procedures of ‘Caffee’, Proclamation No. 153/2009; in accordance to Revised Constitution of Oromia National Regional State, Proclamation No. 46/2001 article 49 sub article 3 it is hereby proclaimed as follows.

1. Short Title

This proclamation may be cited as, "The Proclamation No. 190/2015 to Amend the Organization, Duties, Ethics of the Members and Meeting Procedures of 'Caffee', Proclamation No. 153/2009".

2. Fooyya'iinsa

Labsii Akkaataa Gurmaa'ina, Hojimaata, Naamusa Miseensotaa fi Sirna Walgahii Caffee Mootummaa Naannoo Oromiyaa Irradeebiidhaan Fooyyessuuuf Bahe, Lak. 153/2001 akkaataa kanatti aanee jiruun fooyya'eera.

- 1) Gurmaa'ina Caffee waligalaa Keewwaata 3 Keewwata Xiqqaa 1 (b) jalatti maqaan "Waajjira Afya'a'i fi Caffee" jedhu "Waajjira Caffee" jedhamuun kan fooyya'e yoo ta'u, maqaan waajjirichaa seerota biroo keessatti duraan tuqamee tures haaluma kanaan kan fooyya'e dubbifamu ta'a.

2. Amendment

- 1) The name mentioned as "Office of the Speaker and Secretariat of 'Caffee'" under article 3 sub article 1(b) shall be amended as "Secretariat of 'Caffee'", the previous name of the secretariat in other laws shall be read as conform to this amendment.
- 2) New sub article 4 is added to article 3 that read as, "The 'Caffee' shall have logo that express its distinctiveness". The details shall be enacted by Regulations.

3. Effective Date

This Proclamation shall come into force as of the date of its publication on 'Megeleta Oromia'.
