Proclamation to Provide the Reestab-
lishment of Oromia National Regional
State Secretariat of 'Caffee' Oromia,
Proclamation No. 191/2015

Whereas, the superpower of the Re-
gional State 'Caffee' lead by speaker
and different bodies organized under
'Caffee' in accordance to the Revised
Constitution of the Regional State of
2001 are expected to carry out pow-
ers granted to them according to the
Constitution and other laws in the di-
rection that be acquainted with repre-
sentation of the people;

Whereas, it has become necessary that
the secretariat of 'Caffee' having legal
personality, its organizational structure
and power shall be able in the position
to provide services and professional
support for 'Caffee' and 'Caffee' Or-
gans based on growth, organizational
changes and procedures existing now
and expected for the future;

Whereas, the secretariat based on the organizational structure and power granted to it by the law is obliged to render strong, quality, efficient and effective services and professional support in the activities of law making, over sighting and representation carried out by ‘Caffee’ and ‘Caffee’ organs following parliamentary organization and procedures;

Now, therefore, in accordance to the Revised Constitution of Oromia National Regional State, Proclamation No. 46/2001 Article 49 sub article 3(a) it is hereby proclaimed as follows.

Part One General Provisions

1. Short Title

This proclamation may be cited as, “The Proclamation to Provide for Reestablishment of Secretariat of ‘Caffee’, Proclamation No. 191/2015”.

2. Definition

Unless the context requires otherwise, in this proclamation:

- 1) “Speaker” means the speaker of Caffee Oromia Regional State. .
- 2) “Caffee” means the Oromia National Regional State legislative organ and supreme political power established in accordance to article 46 sub article 1 of the Revised Constitution.
- 3) “Constitution” means the Revised Constitution of Oromia National Regional State.
- 4) “Government” means Oromia National Regional Government.
- 5) “Region” means the Oromia Region.
- 6) “Caffee Organs” means the assembly of the ‘Caffee’, the Secretariat, the Coordinating Committee, the Standing Committees and Whips of political parties having seat in the ‘Caffee’, the ‘Caffee’ affairs Advisory Committee and the ‘Caffee’ group organized in accordance to laws of organization and procedures of the ‘Caffee’.

- 7) “Qaamolee Mootummaa” jechuun Qaamolee seera baasaa / Caffee/, Seera Raawwachiiftuu fi Seera Hiiktuu Mootummaa Naannoo Oromiyaa jechuudha.
- 8) “Seera” jechuun Labsii, Dambii fi Qajeelfamoota Caffee fi qaamolee aangoon kennameef biroottiin bahan jechuudha.
- 9) “Waajjira” jechuun, Waajjira Caffee labsii kanaan qaama seerummaa qabaachuun irra deebiidhaan hundeeffameedha.

3. Ibsa Koorniyaa

Labsii kana keessatti jechi koorniyaa dhiiraatiin ibsame dubartiis ni dabalata.

4. Hundeeffama

- 1) Waajjirri Caffee, (kana booda “Waajjira”) jedhamee beekamuu fi qaama seerummaa qabu labsii kanaan irra deebiidhaan hundeeffameera.
- 2) Ittiwaamamni Waajjirichaa Afyaa'iidhaaf ta'a.

5. Gurmaa'ina

Waajjirri Caffee gurmaa'ina kanatti aanu ni qabaata.

- 1) Ittigaafatamaa Waajjiraa;
- 2) Gorsitootaa fi akka barbaachisummaa isaatti muudamtoota biroo Afyaa'iidhaan ramadamanii fi
- 3) Hojjetootaa fi ogeessota hojiif barbaachisaa ta'an.
- 4) Waajjirichi iskeelii mindaa akka barbaachisummaa isaatti Caffeedhaan murtaa'u qabaachuu ni danda'a.

6. Aangoo fi Hojii Waajjirichaa

Waajjirichi aangoo fi hojii kanatti aananii jiran ni qabaata.

- 1) Caffee, qaamolee Caffee fi gurmaa'inaalee keessoo kanneen biroottiif tajaajila bulchiinsaa ni kenna.
- 2) Hojii seera tumuu, hordoffii fi to'annoo fi bakka bu'iinsa ummataa Caffee fi qaamolee Caffee fi raawwatamuuf deeggarsa ogummaa ni kenna.

፩) የጨፌ ጽህፈት ቤት (ከዚህ በኋላ “ጽህፈት ቤት”) ተብሎ የሚታወቅና ህጋዊ ሰውነት ያለው በዚህ አዋጅ መሰረት እንደገና ተቋቋሟል።

፩) ለጨፌ፣ ለጨፌ አካላትና ሌሎች የውስጥ አደረጃጀቶች አስተዳደራዊ አገልግሎት ይሰጣል።

፪) በጨፌና በጨፌ አካላት ለሚከናወኑ የህግ ማውጣት፣ የክትትልና ቁጥጥር እና የህዝብ ውክልና ስራዎች መያዝ ድጋፍ ይሰጣል።

7) “Government Organs” means the legislative / ‘Caffee’, the executive and the judiciary organ of the Oromia National Regional State.

8) “Law” means proclamation, regulations and directives enacted by ‘Caffee’ and bodies delegated to do so.

9) “Secretariat” means the ‘Caffee’ secretariat reestablished by this proclamation having legal personality.

3. Gender Reference

Provisions of this proclamation set out in the masculine gender shall apply to the feminine.

Part Two

Establishment, Organization and Duties of ‘Caffee’ Secretariat

4. Establishment

- 1) The Secretariat of ‘Caffee’ (herein after referred to as “the Secretariat”) is hereby reestablished by this proclamation having legal personality.
- 2) The Secretariat shall be accountable to the Speaker.

5. Organization

The Secretariat of ‘Caffee’ shall have the following organizational structure.

- 1) Head of the secretariat;
- 2) Advisors and appointees assigned by the speaker as it may be necessary; and
- 3) Necessary employees and professionals.
- 4) The secretariat may have its own salary scale to be determined by the ‘Caffee’.

6. Power and Duties of the Secretariat

The secretariat shall have the following power and duties:

- 1) Render administrative services to the ‘Caffee’, organs of the ‘Caffee’ and other internal structures.
- 2) Provide professional support for the activities of law making, over sighting and people’s representation carried out by the ‘Caffee’ and the ‘Caffee’ organs.

- 3) Caffee fi qaamolee Caffeeitiif galma walga'iiwwanii ni qopheessa; ni mijeesa.
- 4) Qaboowwan yaa'ii Caffee fi qaamolee Caffee, murtiilee fi sanadoota adda addaa sirnaan galmeessee ni qaba.
- 5) Qaamolee fi miseensota Caffeeitiif tajaajila mana kitaabaa, odeeffannoo fi qo'annoo fi qorannoo ni kenna.
- 6) Seerota Caffee fi qaamolee birootiin bahan Magalata Oromiyaa irratti ni maxxansiisa; maxxansaa fi raabsaa seerotaa, barruulee fi maxxansaalee adda addaa ni raawwata; ni raawwachiisa.
- 7) Tooftaalee dandeettii raawwachii-summaa Caffee fi Manneen Maree Ummataa sadarkaa sadarkaan jiran ittiin cimsuun danda'amu baasee hojiirra ni oolcha.
- 8) Ajandaalee fi dokimantoota Walga'ii Caffeeitiif dhiyaatan yeroo dubbisaa seerota hojimaata Caffeeitiin taa'etti miseensota Caffee ni dhaqqabisiisa.
- 9) Keessummoota Caffee fi qaamolee Caffeeitiif tajaajila keessummeessaa barbaachisaa ta'e ni kenna.
- 10) Qabeenya ni horata; waliigaltee ni gala; maqaa isaatiin ni himata; ni himatama.
- 11) Hojiilee gahee Caffee, qaamolee fi miseensota Caffee galmaan gahuu dandeessisan biroo seerarratti hundaa'uun ni raawwata.

7. Muudama, Aangoo fi Hojii Ittigaafatamaa Waajjirichaa

- 1) Ittigaafatamaan Waajjirichaa Afyaa'iidhaan dhiyaatee Caffeehaan kan muudamu ta'a.
- 2) Kallattii Afyaa'iidhaan kennamu bu'uura godhachuun aangoo fi hojii Waajjirichaaf kennaman hojiirra ni oolcha.
- 3) Aangoo fi hojii Waajjirichaa hojiirra oolchuun akkuma eegametti ta'ee, aangoo fi hojii kanatti aana-nii jiran ni qabaata:
 - (a) Karooraa fi baajata waggaa hojiiif barbaachisu qopheessuun karaa afyaa'iitiin Caffeeetti dhiyaatee akka ragga'uu fi hojiirra oolu ni taasisa.

- ፰) ለጨፌ ስብሰባ የሚቀርቡ አጀንዳዎችና ዶክመንቶች በጨፌ አሰራር ህጎች በተቀመጠው ጊዜ ውስጥ ለጨፌ አባላት ያደርሳል፡፡
- ፱) ለጨፌ አካላትና እንግዶች አስፈላጊ የሆነ የመስተንግዶ አገልግሎት ይሰጣል፡፡
- ፲) ንብረት ያፈራል፤ ውል ይዋዋላል፤ በስሙ ይከሰላል፤ ይከሰሳል፡፡
- ፲፩) የጨፌ፣ የጨፌ አካላትና አባላት ድርሻ ለማሳካት የሚያስችሉ ሌሎች ስራዎችን በህግ ላይ ተመስርቶ ያከናውናል፡፡

- ፩) የጽህፈት ቤቱ ሀላፊ በአፈ ጉባኤው ቀርቦ በጨፌ የሚሾም ይሆናል፡፡
- ፪) በአፈ ጉባኤው የሚሰጥ አቅጣጫ መሰረት በማድረግ ለጽህፈት ቤቱ የተሰጡትን ስልጣንና ተግባራት ስራ ላይ ያውላል፡፡
- ፫) የጽህፈት ቤቱን ስልጣንና ተግባራት ስራ ላይ ማዋል እንደተጠበቀ ሆኖ ቀጥሎ የተመለከቱትን ስልጣንና ተግባራት ይኖሩታል፡፡
 - (ሀ) የዓመት ዕቅድና ለስራ የሚያስፈልግ በጀት በማዘጋጀት በአፈ ጉባኤ በኩል ለጨፌ ቀርቦ እንዲጸድቅና ስራ ላይ እንዲውል ያደርጋል፡፡

- 3) Arrange and facilitate meeting halls for the 'Caffee' and the 'Caffee' organs.
- 4) Register and keep properly the minutes, decisions and different documents of the 'Caffee' and the 'Caffee' organs.
- 5) Provide library, information, study and research services for the 'Caffee' organs and members.
- 6) Publish laws enacted by the 'Caffee' and other organs delegated to do so on the Megeleta Oromia; implement and make to be implemented the publishing and distribution of laws, bulletins and different periodicals.
- 7) Prepare and carry out strategy that strengthen the capacity of the 'Caffee' and peoples' Councils exist at all levels.
- 8) Convey agendas and documents for the 'Caffee' members in accordance to the time of reading specified by the 'Caffee' procedural laws.
- 9) Provide necessary cordial reception services for the guests and organs of the 'Caffee'.
- 10) Own property; enter into contracts; sue and be sued in its own name.
- 11) Based on law, implement other activities that enhance roles of the 'Caffee', the 'Caffee' organs and the 'Caffee' members.

7. Appointent, Power and Duties of the Head of the Secretariat

- 1) Under the recommendation of the speaker, the assignment of the head of the secretariat shall be approved by the 'Caffee'.
- 2) Subject to the directives from the speaker, carry out power and duties of the secretariat.
- 3) Notwithstanding to carrying out the power and duties of the secretariat, he shall have the following power and duties:
 - (a) Prepare yearly work plan and budget to be presented by the speaker for the approval of the 'Caffee' and implement the same.

- 2) Grants and support gained from different organs and legitimate sources.

9. Books of Accounts

- 1) The secretariat shall have complete and accurate financial books of accounts.
- 2) Books of accounts and financial documents of the Secretariat shall be audited by the Auditor General of the Oromia National Regional State yearly.
- 3) Notwithstanding the provision under sub article 2 of this article, the speaker of the 'Caffee' any time it deems necessary, can order audit of the account and financial documents.

10. Laws Repealed and Inapplicable

- 1) The Proclamation to Provide for Establishment of Secretariat of 'Caffee', Proclamation No. 47/2001 is repealed.
- 2) Any laws and customary practices that inconsistent with this proclamation shall have no effect with respect to matters included herein.
