WHEREAS, with a view to ensure the peace and security of the region, it is found essential to determine the duties and responsibilities of the people's organization and to precisely provide the collaboration required to exist among the peace keeping bodies;

NOW, THEREFORE, in accordance with Article 49 (3) (a) of the Revised Oromia Regional State Constitution, Proclamation Number 46/2001, this proclamation is hereby proclaimed.

Part One General Provisions

1. Short Title

This proclamation shall be cited as “Oromia Region Gachana Sirna Proclamation Number 245/2022.”

2. Definitions

Unless the context requires, otherwise in this proclamation:

- 1) “Obligation” means obligation given to one to perform a duty legally or by authorized body in the societal organization organized for ensuring peace and security.

- 2) Gachana Sirna” means a system whereby the people in the region can be organized in the cultures and norms of Geda System to protect and defend its interests, benefits and rights.
- 3) “Grade” means the assignment of roles, functions and duties for persons of that age according to the age levels specified in the Geda system.
- 4) “Council” means the Council of Gachana Sirna established at kebele level.
- 5) “Conscious Society” means people of the region aware of its rights, obligations and interests.

10. Structure of Gachana Sirna

- 1) Gachana Sirna shall have structures of sagli, tuta, humna and cibra.
- 2) Gachana Sirna structure shall have its own leadership/chain of command.
- 3) Structuring of Gachana Sirna shall be performed based on the following grades depending on the age levels:
 - (a) Debballe (0 - 8);
 - (b) Gamme (9 - 16);
 - (c) Kusa (17 - 24);
 - (d) Raba (25 - 32);
 - (e) Dori (33 - 40);
 - (f) Geda (41 - 48);
 - (g) 1st Yuba (49 - 56);
 - (h) 2nd Yuba (57 - 64);
 - (i) 3rd Yuba (65 - 72);
 - (j) 4th Yuba (73 - 80).
- 4) Persons specified under level Sub Article 3 (a) and (b) of this Article shall be grown up according to the education and psychological makeup of the people as candidates of Gachana Sirna.
- 5) Persons specified under level Sub Article 3 (c - g) of this Article shall be full members of Gachana Sirna and they shall take part in upholding the peace and stability of the region.
- 6) Persons specified under level Sub Article 3 (h - j) of this Article shall be honorable members of Gachana Sirna and they shall serve it as advisors.
- 7) Particulars of this Article shall be determined by the regulation to be issued.

11. Recruitment

- 1) Member of Gachana Sirna shall be directly selected by the residents of the kebele.

- 2) Any person to be selected as member of the region's Gachana Sirna shall meet the following requirements:
- (a) Shall be resident of the region who respects and protect the culture and value of the region; who can speak the working language of the region properly; who also writes and reads it as may be necessary; below
- (b) Who lived for at least two or more years in the kebele;
- (c) Who has not been serving as member of another peace keeping body;
- (d) Not be below 18 and above 56 years of age;
- (e) Be loyal to the Constitution and Constitutional System;
- (f) Who has won high credibility and ethical conduct amongst the society of the kebele;
- (g) Who has not been criminally charged or punished;
- (h) Who is free from any kind of addiction;
- (i) Who is free from disease that prevent him to serving as member of Gachana Sirna.

12. Capacity Building

- 1) Member of Gachana Sirna shall be provided with training on the necessity of Gachana Sirna, lesson on norms, culture, as to how be organized in Geda system and on other issues that help build up his understanding and mind set or attitude by the concerned bodies.
- 2) Any person selected as a member of Gachana Sirna, shall, before taking up a duty, receive training of physical fitness exercises, military and awareness on human rights.
- 3) Training to be provided for members of Gachana Sirna shall be from time to time; and it may be short-term or long-term training.

4) Military training shall be given by the police of the region; and it may also be provided by other peace keeping bodies as may be necessary.

13. Oath

- 1) Any member of Gachana Sirna who has completed training shall take an Oath.
- 2) Contents of the Oath shall be:
“I-----, while I bear my duty as a member of Gachana Sirna as of today, I hereby promise that being loyal to my country and region, that by respecting and protecting the constitution and other laws, to work for ensuring peace and stability/security, to undertake my duties only in accordance with the law; to perform duties faithfully and fairly through maintaining work confidentiality.”
- 3) Any person not willing to take the Oath specified under Sub Article 2 of this Article shall not serve as a member of Gachana Sirna.

14. Arms

- 1) Armaments of member of Gachana Sirna may be provided by the government and the people.
- 2) A person who is a member or interested to be a member of Gachana Sirna shall use the private arms by registering it in accordance with relevant law.
- 3) While the member of Gachana Sirna who has taken training engage in to duty, he may be armed with firearms if the duty so requires.

15. Bobbii

- 1) Bobbiin Gaachana Sirnaa ajaja hooggansa dhiyoo irraa kennamu-un ta'ee saglii, tuuta, humna yookiin cibraadhaan kan bobbaafaman ta'a.

- 1) Deployment of members of Gachana Sirna shall be by the command of immediate superior; and they shall be deployed in sagli, tuta, humna or chibra.
- 2) Gachana Sirna may be deployed as may be necessary to defend the peace and stability or security of the people.
- 3) The implementation particulars of this Article shall be determined by regulation to be issued.

16. Control Of Weaponry

- 1) Inspection of weapons in the possession of member of the Gachana Sirna shall be performed every six months.
- 2) Any member of Gachana Sirna shall:
 - (a) Bring in person and made registered the weapons at his possession in every six months intervals;
 - (b) Be legally liable where he intentionally or negligently damages or breaks down or make inoperative or transfer to another person or refuse the request to produce back the armaments in his possession for peace keeping purposes, he shall be held accountable;
 - (c) If he negligently vanishes or transferred to another body or sold the weapon without bullet which the government has armed him, he shall be made to reimburse 30 times the price of such weapon;
 - (d) If he lost or fired the bullet provided to him without sufficient reason, he shall be required to pay 10 times the price of such bullet.
- 3) Implementation particulars of this Article shall be determined by the regulation to be issued.

17. Rights

Any member of Gachana Sirna shall have the following rights:

- 2) To express his opinion on the duty assigned to him transparently and freely;
- 3) To get adequate information about the order or instruction assigned to him;
- 4) To appeal against administrative wrongs committed against him and acquire speedy decision;
- 5) To get medical services and supports for the bodily injury, property damage and sacrifice sustained by him or his families;
- 6) If he is a worker, to get leave while he is undergoing duty.

18. Obligation

Any member of Gachana Sirna shall have the following obligations:

- 1) To respect and uphold the constitution and constitutional order;
- 2) To use the weapons he is armed only for the duty he is provided in accordance with the law;
- 3) Person to be selected as a member of Gachana Sirna shall be provided identity card describing as he is a member of Gachana Sirna;
- 4) To respect and uphold the values, laws and principles of human rights;
- 5) To protect the peace and security of his locality in collaboration with the people;

- 7) To be free from bias and benefit seeking practices in discharging his duty;
- 8) To execute and cause to be executed the lawful orders given from his superior;

- 12) To properly protect the advantages and interests of the people and the government as well as the properties provided to him for work purposes;
- 13) To keep the confidentiality of the secrets and information he has known due to his duty;
- 14) To immediately notify information received regarding security threat.

19. Uniform of Gachana Sirna

- 1) Member of Gachana Sirna shall wear a uniform which is different from other peace and security forces when he engages in to peace keeping missions.
- 2) The expense necessary for uniforms of Gachana Sirna shall be covered from the fund.
- 3) The color, manner of procurement and use of uniform of Gachana Sirna member shall be determined by the Directive to be issued.

20. Identity Card

- 1) Identity card prepared by the Office shall be provided to each member of Gachana Sirna.
- 2) Member of Gachana Sirna shall carry identity card describing his job whenever he is deployed for operations; He shall also show same in cases he is requested so.
- 3) Member whose identity card is lost or damaged shall forthwith inform same to the Office.

- 2) Accountability of the Council shall be to the Kebele Administrator.
- 3) Number of members of the Council shall be decided by the Kebele Administrator.
- 4) Implementation particulars of this Article shall be determined by the Regulations to be issued.

22. Power and Duties of the Council

The Council shall have the following power and duties:

- 1) Cause recruitment and selection of Gachana Sirna members to be performed in accordance with the criteria of this Proclamation;
- 2) Work for necessary support to be provided for Gachana Sirna by coordinating the people;
- 3) Provide awareness raising lessons for the society on the necessity of collective peace;
- 4) Follow up the work performances and ethics of Gachana Sirna members; identify the unethical member and advise him; cause necessary measure to be taken where there manifested ethical problems;
- 5) Work for the people to be organized as per the culture and values of Geda System and maintain its peace and security;
- 6) Review the work performances of Gachana Sirna along with the concerned body;
- 7) Accomplish other additional tasks given to it by authorized body.

Part Three

Power and Duties of Various Bodies
23. Power and Duties of Security Council

Without prejudice to those assigned to it by other laws, the Security Council at each level shall have power and duties to:

- 1) Oversee as Gachana Sirna is performing for the purpose it is established; Cause corrective measure to be taken where there exist problems;
- 2) Establish operation system that help to strengthen the work collaborations between Gachana Sirna and other peace and security bodies; cause same to be implemented;
- 3) Follow up and support the work performances of Gachana Sirna; evaluate same; provide feedback;
- 4) Devise various mechanisms that help to build up the performance capacities of Gachana Sirna; cause same to be implemented;
- 5) Facilitate various logistics necessary for the functions of Gachana Sirna; support same;
- 6) Perform other activities that help Gachana Sirna attain its objectives of establishment.

24. Militia Office

Without prejudice to those assigned to it by other laws, the Office shall have following power and duties to:

- 1) Formulate policy, strategy and plan of Gachana Sirna and submit to the concerned body; implement; cause same to be implemented up on its approval;
- 2) Cause members of Gachana Sirna to be selected in accordance with the criteria set; make to be trained; organize and arm them as may be necessary;

- 7) Cause establishment of Gachana Sirna fund; implement and administer same up on its approval; Its implementation particulars shall be determined by the Regulation to be issued;
- 8) Implement; cause to be implemented the award and recognition program to be determined by the Regulation to be issued;
- 9) Perform other tasks that help Gachana Sirna to be successful.

Part Four

Miscellaneous Provisions

25. Source of Budget

Budget of Gachana Sirna shall be covered from the following sources:

- 1) From the fund of Gachana Sirna; and
- 2) Donation and supports obtained from various bodies.

26. Prohibitions

It is prohibited for member of Gachana Sirna to perform the following acts:

- 1) Transferring his firearms to another person illegally;

- (ለ) ለሥራ በሚሰማራበት ጊዜ አባልነቱን የሚገልጸውን መታወቂያ ካርዱ ሳይይዝ ሥራ ላይ ከተገኘ ከስድስት ወር በማይበልጥ ቀላል እሥራት ይቀጣል፡፡
- (ሐ) በሌሎች ሕጎች የበለጠ የሚያስቀጣ ካልሆነ በስተቀር የጋዢና ሲርና አባል በሥራው ምክንያት ያወቀውን ሚስጥር እና መረጃ ለሌላ አካል አሳልፎ የሰጠ እንደሆነ ከአንድ ዓመት በማያንስ እና ከአምስት ዓመት በማይበልጥ ጽኑ እስራት ይቀጣል፡፡
- (መ) በግዴታ ላይ እያለ ህጋዊ ትዕዛዞችን አለመቀበል እምቢተኛ ከሆነ ከአንድ ዓመት በማይበልጥ ቀላል እሥራት ይቀጣል፡፡

- 2) Using private weapon in his possession without getting it registered to the authorized body;
- 3) Failing to carry the identity card describing his membership while he sets out for operations;
- 4) Requiring payment of various benefits by producing false evidences;
- 5) Transferring to other person the secrets and information he has known due to his duty;
- 6) Refusal of the lawful order while he is on duty;
- 7) Impairing the interests of private persons, the public and government by abusing the duty and responsibility entrusted to him.

27. Criminal Penalty

- 1) Any member of Gachana Sirna shall be:
- (a) Punishable pursuant to the relevant laws if he illegally transfers to another person a firearm he has been armed or is found using the private firearm in his possession without registering it with the competent authority;
- (b) Punishable with simple imprisonment not exceeding six months, if he is found on duty without holding identity card describing membership while engaged on duty;
- (c) Unless punishable with more severe penalty under other laws, punishable in rigorous imprisonment not less than one year and not exceeding five years, if he transfers to another body, the secrets and information he has known due to his duty;
- (d) Punishable with simple imprisonment not exceeding one year, if he refuses to obey a lawful order while he is on duty;

- (e) Seera birootiin caalmaatti kan ad-absiisu yoo ta'e malee, gahee hojiifi ittigaafatamummaa itti kenname karaa hin malleen fayyadamuun faayidaa hin malle ofiif yookiin nama biraaf kan argamsiise yookiin faayidaa nama dhuunfaa, ummataa yookiin mootummaa irra miidhaa kan geessise yoo ta'e akkaataa faayidaa argamee yookiin miidhaa dhaqqabeetiin hidhaa cimaa waggaa tokkoo gadi hin taane, waggaa kudhan hin caalleefi adabbii maallaqaa hanga Qarshii kuma digdamaa gahuun adabama;
- (f) Seera birootiin caalmaan kan ad-absiisu yoo ta'e malee, gochaalee Labsii kanaan dhorkaman biroo raawwatee yoo argame hidhaa salphaa baatii jaha hin caalleen yookiin adabbii maallaqaa Qarshii kuma shan hin caalleen adabama.
- 2) Seera biraatiin caalmaan kan adabsiisu yoo ta'e malee, namni kamiyyuu ragaa sobaa dhiyeessuun fayidaalee adda addaa akka raawwatamuuf kan gaafate yookiin kan fudhate yoo ta'e, hidhaa cimaa waggaa sadii hanga waggaa kudhaniitiin adabama.

28. Dirqama Deeggarsa Kennuu

Namni kamiyyuu dhimmoota Labsii kana keessatti hammataman hojiirra oolchuuf deeggarsa kennuuf dirqama qaba.

29. Seerota Raawwatiinsa Hin Qabaanne

Labsiin, Dambiin, Qajeelfamni yookiin barmaatileen hojii Labsii kanaan walfaallessan kamiyyuu dhimmoota Labsii kana keessatti hammataman irratti raawwatiinsa hin qabaatan.

(ሠ) በሌሎች ሕጎች የበለጠ የሚያስቀጣ ካልሆነ በስተቀር የተሰጠውን ተግባርና ኃላፊነት ያለአግባብ በመጠቀም የማይገባ ጥቅም ለራሱ ወይም ለሌላ ሰው ያስገኝ ወይም በግልሰቦች በሕዝብ እና በመንግሥት ጥቅም ላይ ጉዳት ያስከተለ እንደሆነ እንደተገኘው ጥቅም ወይም እንደደረሰው ጉዳት ሁኔታ ከአንድ አመት በማያንስ እና ከአሥር አመት በማይበልጥ ጽኑ እስራት እንዲሁም እስከ ሃያ ሺህ ብር በሚደርስ የገንዘብ መቀጮ ይቀጣል።

(ረ) በሌሎች ሕጎች የበለጠ የሚያስቀጣ ካልሆነ በስተቀር፣ በዚህ አዋጅ የተከለከሉ ሌሎች ድርጊቶችን በመፈጸም ጥፋተኛ ሆኖ ከተገኘ ከስድስት ወር በማይበልጥ ቀላል እሥራት ወይም ከአምስት ሺህ ብር በማይበልጥ የገንዘብ መቀጮ ይቀጣል።

2) በሌሎች ሕጎች የበለጠ የሚያስቀጣ ካልሆነ፣ በስተቀር ማንኛውም ሰው የሀሰት ማስረጃ በማቅረብ የተለያዩ ጥቅማ ጥቅሞችን እንዲፈጽሙለት የጠየቀ ወይም የተቀበለ እንደሆነ ከሦስት እስከ አሥር ዓመት በሚደርስ ጽኑ እሥራት ይቀጣል።

28. ድጋፍ የመስጠት ግዴታ

ማንኛውም ሰው በዚህ አዋጅ ውስጥ የተሸፈኑትን ጉዳዮች ተግባር ላይ ለማዋል የሚፈቃድ ድጋፍ የመስጠት ግዴታ አለበት።

29. ተፈጻሚነት የማይኖራቸው ሕጎች

ከዚህ አዋጅ ጋር የሚቃረኑ ማንኛውም አዋጅ፣ ደንብ፣ መመሪያ ወይም ልማዳዊ አሰራር በዚህ አዋጅ ውስጥ በተካተቱ ጉዳዮች ላይ ተፈጻሚነት አይኖራቸውም።

(e) Unless punishable with more severe penalty under other laws, punishable with rigorous imprisonment not less than one year, not exceeding ten years and fine up to twenty thousand birr, depending on the benefit acquired or damage caused, if he impairs the interests of private person, of the public or government by abusing the duty and responsibility entrusted to him.

(f) Unless punishable with more severe penalty under other laws, punishable with simple imprisonment not exceeding six months or fine penalty not exceeding five thousand birr, if he is found committing other acts prohibited under this proclamation.

2) Unless punishable with more severe penalty under other laws, any person who requested or received various benefits by presenting false evidence shall be punishable with rigorous imprisonment from three years to ten years.

28. Obligation to Cooperate

Any person is obliged to cooperate for the implementation of matters covered under this Proclamation.

29. Inapplicable Laws

Any Proclamation, Regulation, Directive or customary practices in contradiction with this Proclamation shall not be applicable on the matters covered under this Proclamation.

30. Aangoo Dambiifi Qajeelfama Baasuu

- 1) Manni Maree Bulchiinsa Mootummaa Naannoo Oromiyaa Labsii kana raawwachiisuuf Dambii baasuu ni danda'a.
- 2) Waajjirichi Dambii bu'uura Labsii kanaatiin bahu raawwachiisuuf Qajeelfama baasuu ni danda'a.

31. Yeroo Labsichi Hojiirra Itti Oolu

Labsiin kun guyyaa Magalata Oromiyaa irratti maxxanfamee bahe irraa eegalee hojiirra kan oolu ta'a.
